Assessment governance for \$265 Billion in property assessment base

The property tax base provides over \$2.1B in revenues for municipalities and the education sector

- \$1.4B for municipalities
- \$735M for education



FOUR-YEAR FUNDING PLAN 2022-25:

CORE SERVICES

Accurate and timely property maintenance by request of municipalities

- Property inspection reviews to keep the province on schedule for a complete reinspection cycle of 12 years
- Professional and effective support of value services for all client municipalities
- Continual review of property transactions, staying abreast of trends and changes to deliver a high-quality provincial revaluation for 2025
- Provide updates and timely information to all stakeholders while keeping lines of communication open



2022 BUSINESS AND FINANCIAL PLAN

- Key activities
 - Conduct 110,000 property reviews
 - Represent SAMA's clients in estimated 2,000 property appeals
 - Continue research and analysis towards the 2025 revaluation
 - Continue governance activities: provide quality assurance service, maintain central assessment database, continue to provide assessment policy updates
- Maintain same staffing levels
- CEO Vision: Increased focus on quality

PROGRESS AND CHALLENGES

2021 stood out for a couple of reasons

- Provincial-wide revaluation
- 2nd year of the COVID-19 pandemic

Hybrid remote work model / pilot continued successfully

A record number of property inspections completed in a revaluation year

2021 was the final year of the 2018-2021 4-year planning cycle – beat our goal of 420,000 reviews by completing 429,000 reviews

PROGRESS AND CHALLENGES CONT'D

Fewer property appeals than in prior revaluation (3,855 appeals in 2021)

Many related to complex issues on high value properties

External legal costs well over budget due to the number of appeals, many at higher courts
