### **Comments/Questions**

<u>Canadian Property Tax Association:</u> From industry's perspective, additional inspections are beneficial as it ensures each sector in the province pays their fair share of property taxes.

<u>SAMA Administration:</u> Thank you for the comment. These inspections allow SAMA to meet our goals of creating fairness and equity in the assessment system.

<u>SAMA Board:</u> Have the coal mines begun to see a reduction in their assessment with their scheduled phase out in 2030?

<u>SAMA Administration</u>: Currently, SAMA has not seen this reflected in their assessment values. There are yearly fluctuations in their assessment depending on the amount they utilize resource production equipment in a particular roll year.

<u>Saskatchewan Association of the Appraisal Institute of Canada:</u> Is the 12-year inspection cycle for properties legislated in Saskatchewan?

<u>SAMA Administration</u>: There is nothing currently within legislation to outline SAMA's 12-year inspection cycle. SAMA has determined this cycle based upon the resources at our disposal at the current time.

<u>Saskatchewan Association of the Appraisal Institute of Canada:</u> It is appreciated that SAMA maintains a 12-year cycle without legislation.

7c. Other Assessment Service Provider (ASP) Updates (Saskatoon / Regina / Prince Albert / Swift Current)

City of Saskatoon Update: Verbal presentation by Bryce Trew

<u>2023 Assessment Roll Update:</u> The City of Saskatoon's assessment roll opened on January 3, 2023 and closed on February 3. Saskatoon received 577 appeals to the Board of Revision (BOR); this appeal count is higher than prior revaluations.

The Saskatoon BOR's goal is to have all appeal decisions rendered by July 4, 2023. Approximately 90% of BOR appeal hearings have been scheduled during March and April.

<u>Appeal Update:</u> Saskatoon has two appeals at the Court of Appeal (CoA). One appeal has been granted leave and another is awaiting the decision for its leave application.

Regarding Saskatchewan Municipal Board (SMB) appeals, Saskatoon has approximately 60 appeals remaining on the 2022 Assessment Roll.

<u>2025 Revaluation:</u> In February, Saskatoon forwarded requests for information to commercial property owners. If necessary, Saskatoon

will send reminder letters as receiving this information is a key component for analyzing commercial models for the January 1, 2023 Base Date. Saskatoon is also planning to perform an in-depth review of market areas for commercial properties this revaluation.

Residential sales are currently being verified and Saskatoon is anticipating beginning condominium analysis in April.

<u>Staffing:</u> City of Saskatoon staff continue to work on a hybrid schedule of two days at home and three in the office. Saskatoon is looking to fill two permanent and one temporary position in the assessment department.

City of Regina Update: Verbal presentation by Colinda Johnson

<u>Staffing:</u> Regina is looking to fill one vacancy for an assessment coordinator position.

<u>2023 Assessment Roll Update:</u> Regina's assessment roll opened on January 3, 2023 and closed on February 3. Regina received 77 appeals to the BOR, of which 7 have been withdrawn by the appellant.

Regina's BOR is also anticipating that decisions will be rendered by July 4, 2023. The appeal hearing dates will likely be in April/May.

Regina will be forwarding updated property tax bills on June 1, 2023. The property taxation increase is around 3.67%.

<u>Appeal Update:</u> Regina has two recent CoA decisions (Southland Mall and Boardwalk) that have been remitted to the SMB for de novo hearings. Case management for these appeals began in December 2022 and Regina is anticipating that the hearings will be scheduled in June 2023.

Regina has received requests for information from the appellant for Southland and Boardwalk and has been continuing to work on providing information ahead of the hearing date.

<u>2025 Revaluation:</u> Regina is reviewing and verifying residential and commercial sales for the upcoming revaluation. In February, requests for information, on income and expense data, were forward to approximately 200 property owners of multi-residential, commercial, and industrial properties.

Regina is seeing preliminary trends of an approximate 6% increase to single family residential, 2% decrease for condos, 15% decrease on multi-residential properties, and commercial properties having a 1-2% increase.

<u>Other Projects:</u> Regina is updating their CAMA system from an Oracle based platform to a Microsoft.net program. The final changes from this conversion are scheduled to be completed in 2023/2024.

Regina is also a representative on the SUMA working group to review the IPTI Assessment System Review recommendations.

City of Prince Albert Update: Verbal presentation by Vanessa Vaughan

<u>Staffing:</u> The City of Prince Albert is fully staffed with five appraisers and a city assessor. Prince Albert staff continue to work fulltime in City Hall.

<u>2023 Assessment Roll Update:</u> Prince Albert's assessment roll opened on January 11, 2023 and closed on February 10. For 2023, there have been 72 appeals launched to the BOR with two appeals denied due to insufficient appeal grounds. Like Saskatoon, this is a higher quantity of appeals than normal.

Prince Albert is in the process of performing appeal inspections on these properties ahead of discussing the appeals with the property owners and/or tax agents.

<u>2025 Revaluation:</u> Prince Albert is working on sales verification of the various property types for the upcoming revaluation.

For the 2025 Revaluation, Prince Albert will be performing an in-depth review and reinspection of condominiums to allow for additional physical characteristic testing when constructing the condo model.

Prince Albert has forwarded requests for information to commercial property owners, which have a response rate around 60%. Prince Albert will be investigating the application of the income approach to commercial properties in 2025, so requests for income and expense data will be forwarded to those property owners in April.

Due to appeal work for 2023, Prince Albert is planning to complete assessment modeling for condos, residential, and land models by the end of 2023. The model for multi-family residential will tentatively be complete by end of 2023/early 2024, and the commercial/income model will tentatively be complete ahead of the April 1, 2024 preliminary value deadline.

<u>City of Swift Current Update</u>: Verbal presentation by Julianne Rempel.

<u>Staffing:</u> Swift Current remains fully staffed and continues to work out of City Hall.

<u>2022 Supplemental Assessment Roll:</u> Swift Current had 9 appeals on the supplemental roll. These appeals were dismissed by the BOR.

<u>2023 Assessment Roll Update:</u> Swift Current's roll is scheduled to open during the week of March 27, 2023.

<u>Appeal Update:</u> Swift Current has no outstanding appeals at the SMB or CoA.

<u>2025 Revaluation:</u> Swift Current is focusing on sales verification and sending out requests for information for the upcoming revaluation.

Other Work: Swift Current is also investigating an update to their CAMA system. Additionally, Swift Current is working on enhancing

communication with property owners through social media engagement.

<u>SAMA Board Member:</u> Are the appeals in Saskatoon focused on a particular segment of properties?

<u>City of Saskatoon:</u> The appeals are on several properties that are represented by the same tax agent.

<u>SAMA Board Member:</u> Is there a common element of the recent turnover of staff with the assessment service providers (ASPs)?

<u>SAMA</u> and <u>Other ASPs:</u> In general, most are related to retirements. To fill these positions, it has been more successful to develop individuals already employed by an ASP.

However, this remains a potential risk area for the future as experienced employees retire in the province.

<u>Saskatchewan Association of the Appraisal Institute of Canada:</u> Why has the SUMA working group selected elimination of provincial percentages of value, shortening the revaluation cycle to 1 or 2 years, updating the base date to 12 months prior to a revaluation and moving to true market values for regulated and non-regulated properties as the recommendations from IPTI to focus on?

<u>SAMA Administration</u>: The SUMA working group has been asked by their City Mayors' Caucus to focus on these options for change as they likely perceive these as having the greatest merit and potential for positive change for the property assessment system.

<u>SAMA Board Member:</u> Regarding moving to true market value for all properties, the agricultural sector prefers the existing regulated model

as it accounts for key factors such as soil type, topography, climate, and miles to market.

#### 10. Government Relations Update

PowerPoint presentation by Abayomi Akintola, Ministry of Government Relations

The Ministry of Government Relations began the Board of Revision (BOR) initiative in 2018 based upon feedback from various stakeholders that improvements should be made to the appeal process in Saskatchewan.

The four key components of the BOR initiative are:

- 1. To have a provincial registrar office to ensure BORs across the process have access to required training and knowledge,
- 2. To establish standard training for all BOR members, secretaries, and chairs,
- 3. To establish a centralized BOR that municipalities can utilize should they choose not to establish their own BOR, and
- To establish an Advisory Committee that will monitor the system regarding performance, efficiency, effectiveness and to put forth recommendation to the Ministry of Government Relations.

For the 2023 Assessment Roll, all local BORs members and secretaries are required to be certified and have taken the BOR training that was developed through collaboration with the Johnson Shoyama Graduate School of Public Policy.

<u>Training Status Update:</u> There have been 263 participants in the BOR training. Currently, 223 participants have successfully completed the training. There are 121 discounted training spots, made available through the Targeted Sector Support Initiative, open to individuals who would like to take the course.

<u>Certification of BORs:</u> It is the responsibility of the BOR, not the municipality, to complete the online certification. Currently, there are 19 certified BORs in Saskatchewan. The current list of certified BORs can be reviewed here <u>saskatchewan.ca/board-of-revision-certification-and-training</u>.

<u>Centralized BOR:</u> The centralized board of revision (CBOR) can serve any municipality should they decide, or be unable, to appoint their own BOR. The CBOR is an additional option and will ensure ratepayers receive quality and fair appeal services. Currently, 32 municipalities have appointed the CBOR for their 2023 appeal services.

Advisory Committee: The final component of the BOR initiative is the Assessment Appeal System Advisory Committee. The primary objective of the committee will be to put forth recommendations to improve the first level of assessment appeals and monitor if additional changes are required for training, certification or the CBOR.

The Ministry of Government Relations is continuing to review and determine the structure of the Advisory Committee. In general, the Committee will likely include representatives from SUMA, SARM, SAMA, RMAA, UMAAS, the SMB and the Ministry of Government

Relations. The Ministry of Government Relations is tentatively planning that the Committee will be formed by the fall of 2023.
